# Minutes of the Board of Directors Meeting December 1, 2009 White Plains Public Library

The meeting came to order at 10:10 A.M. Motion (Thaler/Reznick) to accept the Minutes from November 5, 2009, passed.

# **Treasurer's Report:**

• Falcone reported that as of November 27, 2009, WLA had \$9,071.44 in the Checking Account and \$30,006.83 in the Savings Account with a combined total of \$39,078.27.

### **College Section:**

- Batemarco reported that she has one confirmed speaker for the Annual Conference. Kate Todd, Emerging Technologies Librarian at Manhattanville College, will discuss *Libraries*, *Literacy and Gaming: a Manhattanville College grant*.
